

Winter Resolution 2018 Sweepstakes

OFFICIAL RULES

No purchase, obligation or transaction necessary TO ENTER THE SWEEPSTAKES.

Promotion Period: Winter Resolution 2018 ("Sweepstakes") begins January 1, 2018 and ends February 28, 2018. Entries received prior to or after the Promotion Period are not eligible for the Sweepstakes.

How to Enter: Individuals will receive an automatic entry into the Sweepstakes when they log into [PARTNER COLORADO CU MY FINANCIAL PARTNER] between January 1, 2018 and ends February 28, 2018, and have added at least one Goal. One entry per household.
